Shangana Press 2025 Irish Theatre Tour Terms and Conditions

INCLUDED:

Tour of 11 days/10 nights, admission to eight performances, double (or single) accommodations in Dublin and Galway with breakfast all days, three dinners, two day trips, transport Galway to Dublin, meetings with theatre artists (such as playwrights, directors, and designers), and other activities. Due to unforeseen circumstances, some details may change as we approach the tour date. If any substitutions are necessary, to the best of our ability they will be of equivalent value. Due to rules and restrictions imposed beyond our control by governments, companies, and individuals because of the COVID pandemic (such as restrictions on indoor activities, group sizes, theatres, or dining establishments), it is possible that the quantity of performances, meals, and other activities may be reduced.

NOT INCLUDED:

Airfare; any extra charges you incur in your room, such as mini-bar, laundry, and phone calls; any meals not included above; taxi or transport to locations within walking distance (almost all the theatres and restaurants are).

COVID-19:

Currently there are no requirements. However, we reserve the right to impose vaccination and/or masking requirements at our discretion, depending on world health conditions, and by registering you agree to abide by our requirements in effect at the time of the trip. Falsification of any documents, refusal to follow any COVID precautions imposed, or refusal to follow direction by the group leaders in regards to COVID precautions, will result in immediate removal from the trip with no refund due.

PAYMENTS:

Online registration must be followed up within 5 days by the signing of this document and receipt of your first payment of \$1000 (\$750 through July 10) to Shangana Press to hold your place. The second payment of \$1350/person (\$1850 single occupancy) is due on Jan 30, 2025, and the third payment of \$1350/person (\$1850 single occupancy) is due on March 31, 2025. Payment by check is generally preferred. If you wish to pay by credit card or PayPal, a fee will be added to cover our expenses in processing the transaction.

CANCELLATION:

If you cancel within 5 days of signing this document and our receipt of your first payment, whichever is later, you will receive a full refund. Payments are otherwise non-refundable. Failure to meet a payment deadline (with a grace period of 5 days) will be assumed to be a cancellation. In the event that you decide to rejoin the tour (subject to availability), there will be a \$250 per person administrative fee. Cancellations must otherwise be made in writing. Once the tour has started, there will be no refunds for unused portions of the tour for any reason. In the event that

Shangana Press must cancel the trip, due to acts of nature, war, pandemic, terrorism, or any other unforeseen event, Shangana Press will offer a full refund. You may wish to purchase your own trip cancellation insurance.

GROUP SIZE:

If a minimum of 14 paid participants do not register, we reserve the right to cancel the tour and refund any amounts paid. The maximum number of participants will be 24 persons.

MINORS:

Minors under 18 must be accompanied by a parent or guardian. Exceptions may be granted for mature individuals by prior arrangement.

LIABILITY:

I understand that travel can be dangerous and waive any liability against Shangana Press (including its employees, officers, contractors, and volunteers) for any injury, death, loss, damage, accident, expense, or delay, caused during the tour, including but not limited to incidents related to transportation or lodging services.

Shangana Press assumes no responsibility or liability in connection with the services of any train, vessel, carriage, aircraft, or other conveyance that may be used wholly or in part in the performance of their duty to travelers; neither will Shangana Press be responsible for any act, error, or omission or for any injury, loss, accident, delay or irregularity that may be occasioned by reason of any proprietor, or for any other person engaged in carrying out the purpose for which tickets or coupons are issued.

I understand that there is a risk of getting infected by Covid or other communicable diseases, and I assume full personal responsibility and risk, and agree to hold Shangana Press harmless in the event that I become infected.

Shangana Press reserves the right to decline to accept or retain any traveler as a member of the tour at any time, in the event that it becomes necessary or advisable for the comfort, safety, or well-being of the leaders, other participants, or the public. I understand that if I am asked to leave the tour under this policy, either before or after it has started, no refund or compensation shall be provided. In the event that it becomes necessary or advisable for the comfort, safety, or well-being of participants, for any reason whatsoever, to alter the itinerary or arrangements, such alterations may be made without penalty to Shangana Press.
